## INDUSTRY UPDATE SERVICE DELIVERY MODEL FOR PERMITS AND INSPECTIONS

EFFECTIVE January 14, 2021

In a continued effort to slow the spread of COVID-19, the Provincial government announced that effective January 14, 2021 at 12:01am Ontario will move into a "Stay-at-Home Order" and introduce enhanced enforcement measures to reduce mobility, requiring everyone to remain at home.

The Province has indicated that non-essential construction will be further restricted to enhance public health and workplace safety measures during the province-wide shut down. In order to do our part in mitigating the spread of the COVID-19 virus, the Building Division will continue to maintain strategic modifications to our service delivery. Current Building Division services are outlined below.

### **BUILDING DIVISION SERVICES**

#### **Building Division – Inquiries**

In-person Building Division inquiries will not be available. Please contact our Permit Services Clerk at (519) 255-6267 Ext. 6862 or email <u>buildingdept@citywindsor.ca</u> for all inquiries.

### **Building Permit Application – Submissions**

Building Permit Application submissions will continue to be accepted online through the E-services building permit page located on the City's website <u>www.citywindsor.ca</u>.

#### **Building Permit Application - Plans Review**

Building Permit Applications will continue to be reviewed by our Plans Examination Staff.

#### **Building Permit Application – Permit Issuance**

Once an application has completed the review process, the applicant will be notified by email that their permit is ready for issuance and payment is required.

#### **Building Permit Application – Payments**

Building permit payments will continue to be processed on Tuesdays and Thursdays only. Payment will not be processed in person and payment-processing timelines may be temporarily delayed. Permit applicants will continue to receive email notifications when payments are processed.

#### Inspection Scheduling

Our Dispatch can be reached by phone at (519) 255-6453 or email <u>dispatch@citywindsor.ca</u>. Emails and calls will be answered Monday through Friday between 8:00 am and 2:00 pm. Inspections will only be permitted and scheduled for permitted construction activities. Depending on the type of the inspection request, the inspection may be scheduled as an In-Person Site Inspection or a Virtual/Remote Inspection.

#### Inspections

In-person site inspections will only be performed when there are **no** workers on site. When this cannot be accommodated, other safety measures will be required in order for the inspection to be performed.

In all our efforts, we will strive to continue to be responsive to the construction industry's needs, and above all, we will continue to take all necessary precautions regarding staff, site and community safety. Thank you for your continued assistance and cooperation.

There will be a combination of measures that come into effect between Tuesday January 12, 2021 and Thursday, January 14, 2021, including a provincial declaration of emergency under the <i>Emergency Management and Civil</i> <i>Protection Act</i> , orders under that Act, and amendments to regulations under the <i>Reopening Ontario (A Flexible</i> <i>Response to COVID-19) Act, 2020.</i>	The enhanced public health and workplace safety measures are in effect <b>for all of Ontario</b> and are anticipated to be in place until at least Thursday, February 11, 2021.

## (UPDATED) General Public Health Measures for all Individuals

Stay-at-Home

## Physical Distancing

Every person in a place of business or facility that is open to the public shall maintain a physical distance of at least two metres from every other person except from their caregiver or other members of the person's household, with limited exceptions.

#### Face Coverings

Every person in the premises of a business or organization that is open shall ensure that they wear a mask or face covering that covers their mouth, nose and chin, when they are in indoor areas of the premises, with limited exemptions.
